1. Who we are and what we do

The Jersey Green Room Club (**JGRC**) is a local amateur dramatic club which produces musicals, plays, pantomimes and workshops directed by a variety of talented and imaginative directors, choreographers and musicians.

2. Data needed to support these activities

The JGRC is subject to the Data Protection (Jersey) Law 2018 in addition to the General Data Protection Regulation which requires the JGRC to maintain details of all its members (name, address, email, telephone, mobile numbers).

3. What do we do with this data

During productions we may take photographs, videos and film footage (including media coverage) and use these images for marketing the production. We may also use the images on the JGRC Website and/or Social Media.

4. How we store and retain your information

Membership Forms are stored both electronically on the JGRC Laptop with any paper copies stored in a lockable cupboard at the JGRC Clubroom. Both electronic copies and paper copies are only accessible to the Committee Officers of the JGRC. Information is stored for 14 months before being destroyed (unless a membership is renewed).

Audition Forms are stored via paper copy in a lockable cupboard at the JGRC Clubroom and accessible only to the Committee Officers of the JGRC and the Production Team. These forms are stored for a period of 6 months before being destroyed.
